# **CLOCK HOURS**

Advisers who are registered for our Virtual SBLC, will be able to receive up to 15 clock hours for our Virtual SBLC. Because we are virtual there will be a slightly different process.

### **COMPETITION LIMITS**

With our Virtual SBLC this year, the limits for competitive events have changed. All competitors are eligible to compete in up to six (6) events for this conference with a maximum of three (3) of these being performance/demonstration/interview events; i.e., 3 objective tests + 3 performance events OR 6 objective tests OR 4 objective tests + 2 performance events OR any combination of 6 with no more than 3 performance events. The requirement for students to have qualified in a competitive event has been waived this year.

## **ONLINE TESTING**

All chapters attending SBLC with at least one student in an online test should have received an email from TFI with your adviser credentials. These can be used to access your student login cards. This same credential will be used after SBLC for you to see more information on the testing results.

Please consider testing your students earlier rather than later. All tests must be completed by 5:00 PM on April 24.

All Parliamentary Procedures teams need to have all team members taking their individual tests at the same time. If you did not receive your testing login, please let us know.
