PBL State Conference—Judges Needed!

Centralia College FBLA-PBL (Future Business Leaders of America) is hosting the state competition for both Washington and Oregon here on campus. The event is Friday, February 23-Saturday, February 24. Students from various colleges in Washington and Oregon will be competing in events such as accounting, business law, computer applications, emerging business issues, financial analysis, management, and marketing.

To make this event possible, individuals are needed to judge events. Possible judging events include case study roleplays, interviews, presentations, and speeches. Competition information and rubrics are provided to judges - you just have to ask questions and score students. Judging occurs from about 3-5pm on Friday and 8am-1pm on Saturday.
