## **COMPETITIVE EVENTS**

Competitive events registration closed on Friday, May 29. Please check your email for a message from the National Center. We are asking you to check the competitive event registration report for your state, and to let us know if everything is correct. This report contains each competitors ID number, and that is their password into the online testing system if they are registered for an objective test event.

An email has also been sent to local advisers to check their chapter's competitive event registration. Local advisers have been asked to let their state adviser and the National Center know if any changes are needed.

Local advisers have been sent an email that lists all their member who will be taking an online, objective test. The email contains logins/passwords to ESESS, along with needed instructions.

# Online, Objective Test Instructions and Logins/Passwords

### GENERAL INFORMATION

Students may log in to ESESS any time to take their tests—we do not have scheduled times for the tests this year. However, please keep in mind, that some tests have to be completed sooner than others. Here is the schedule:

- June 1-3: Testing window for Future Business Leader (FBLA)
- June 1-9: Testing window for all role play events (identified as Objective Test and Role Play events on <u>www.fbla-nlc.org</u>)
- June 1-26: Testing window for all other objective test events

### PRACTICE TESTS

It is recommended that students do a SAMPLE TEST on the device they plan to use for testing. The sample test is available at:

### **TESTING INSTRUCTIONS**

Here are the instructions for online testing for the 2020 National Leadership Experience:

- For tests that allow the use of calculators, students will be able to access a calculator as part of the online test. They should not use any other calculators.
  - EXCEPTION FOR PBL ONLY: If you are taking an accounting, finance, or analysis & decision making test, you may use a financial calculator.
- Due to COVID-19, we are not using proctors this year, which is why every student has been required to complete the honor code. Please use honesty, respect, and integrity for this process. Test questions MUST NOT be shared with others.
- Once an online test begins, the clock may **NOT** be stopped and the test will close at the end of the allocated time.

  - PLEASE NOTE that competitors can log on and take their test any time, but if a problem occurs, assistance is only available from TFI between the hours of 8 a.m. to 5 p.m. (U.S. central time).

- To access the test:
  - Competitors should go to the following website: <u>https://www.techfluency.org/esess/</u>
  - Prior to logging in, the competitor can access the "<u>Participant Guide</u>" on the left to receive instructions about the testing platform. This does not count as part of their time (as long as they have not started a test) and can be reviewed prior to the testing window.



- To log in to the test:
  - Enter the Organization (it will be either FBLA, ML, or PBL)—it is NOT the name of your school.
  - Enter First Name, Last Name, and the Password (which is labeled "Individual record number") typed exactly as it is provided in the attached spreadsheet. These must be entered exactly as provided, even if a name is misspelled.
  - Click Log in.
  - Students will need to read the "General Instructions" and must agree to all of the check boxes before they can click Continue to move into the test.
  - Students will click the "Begin" button to start the selected assessment. Do NOT click this button before you are ready to start.
- $\circ$  To take the test:
  - Select your answer and choose Save Answer or Next.
  - To activate the built-in calculator, click the calculator icon at the top of the page.
  - After you are done reviewing all items, click "Submit for Grading," close the page, and log out. You do not need to print the page.
