National Database Updates.

- **Print Invoices.** When you log in to your chapter membership record, you should click on “**Your Chapter.**” Then click on, “**View/Print Invoice.**” An overall Invoice number has been added and the word “Invoice” has replaced the word “**Order**” to help meet district requirements to issue school checks for payment for both membership and conference registration.
- **Remove Button.** The “**Remove**” button will not be added back to the chapter roster. There is too big of a margin for error with creating duplicate members. Please email membership@fbla.org if you need students removed from your roster. This is the same process that we have used in the past.
- **Manage Students.** All functionality for managing students can be found under the “Manage Students” tab.

- **Professional Members.** Professional members renewing their membership should activate their account using the [Activate Your My FBLA-PBL Account](#) button on the website. All new professional members should click the [Join](#) button under the PD tab on the home page of the national website and complete the application.
